REPLY ARGUMENT

The state's argument that the court rely on *Townsend v. State*, 681 So.2d 497 (Miss. 1996) to affirm is unpersuasive. In *Townsend* the officer was asked to retrieve personal property from Townsend's car and smelled marijuana, thus providing probable cause for a subsequent search. Contrarily, in this case there was no consent nor request for the officers to enter Johnson's automobile at any time.

"Townsend initiated the request for the officers to return to his car." 681 So. 2nd at 501. That is when the officers's smelled burned cannabis. "And the smell of marijuana gave Officer Turner and fellow officers all the probable cause needed to conduct a more probative search of the area that was within Townsend's immediate control." *Id.* at 504.

There is no analogy between Johnson's case here and *Townsend* or any of the other authorities cited by the state. The more recent cases cited by the appellant in his initial brief, none of which were distinguished by the state, appear to control.

Otherwise, Johnson relies on the arguments previously presented.

CONCLUSION

Johnson respectfully requests to have his conviction reversed and remanded for a new trial.
