#### STATEMENT OF THE ISSUE

## I. BERRYHILL'S MOTION FOR POST-CONVICTION RELIEF WAS PROPERLY DISMISSED AS BOTH SUCCESSIVE WRIT-BARRED AND TIME-BARRED.

#### **PROCEDURAL HISTORY**

On February 14, 1995, Anthony Mark Berryhill pled guilty to murder in the Alcorn County Circuit Court. C.P. 63-76. Berryhill twice moved for post-conviction relief in the trial court on November 20, 1997 and February 2, 2001. While the record is unclear as to whether Berryhill sought appellate review of the 1997 denial of relief, he did file a notice of appeal regarding the 2001 denial. However, Berryhill's appeal was ultimately dismissed for his failure to file an appellate brief. See attached exhibits.

On October 27, 2006, Berryhill filed a third motion for post-conviction relief in the trial court. C.P. 2-58. The petition was dismissed upon a finding that it was procedurally barred as a successive writ. Berryhill now appeals his third denial of post-conviction relief.

## SUMMARY OF ARGUMENT

Berryhill's most recent motion for post-conviction relief was both successive writ-barred and time-barred. He neither argues nor meets any of the exceptions to the procedural bars. Accordingly, the trial court properly denied relief.

#### ARGUMENT

## I. BERRYHILL'S MOTION FOR POST-CONVICTION RELIEF WAS PROPERLY DISMISSED AS BOTH SUCCESSIVE WRIT-BARRED AND TIME-BARRED.

Mississippi Code Annotated § 99-39-23 provides that "any order dismissing the prisoner's motion or otherwise denying relief under this article is a final judgment and shall be conclusive until reversed. It shall be a bar to a second or successive motion under this article." As stated above, the trial court had twice denied Berryhill post-conviction relief in 1997 and 2001, prior to his third filing in 2006. Because the 1997 order was never reversed, it was conclusive and stood as a procedural bar to the 2001 and 2006 motions. Further, Berryhill does not allege nor meet any of enumerated exceptions found in Mississippi Code Annotated § 99-39-23 (6).

Additionally, because Berryhill pled guilty in 1995, his most recent motion for postconviction relief was also time-barred by Mississippi Code Annotated § 99-39-5(2). Accordingly, the trial court properly dismissed his motion for relief.

## CONCLUSION
