REPLY ARGUMENT

Issue No. 1: Prior Bad Act Evidence

The state asserts that Logan did not challenge the relevancy of the prior bad act evidence as to motive, opportunity, intent, preparation, plan knowledge, identity or absence of mistake. [State's Brief 16-17]. Logan takes exception to this conclusion. The appellant's motion in limine and defense counsel's statements at trial make it clear that introduction of the alleged prior bad acts evidence was opposed because it was not probative of any material issue and that even if it were, the prejudice of the evidence outweighed any arguable probative value. Otherwise, the state's position is unpersuasive. *Robinson v. State*, ___ So. 3d ___ (Miss. Ct. App. 2009) (2007-KA-2202 COA) (¶13).

Issue No. 2: Weight of Evidence

Under this issue, the appellant rests on his initial brief and authorities therein.


CONCLUSION


