monies she diverted from Akins; she kept some of the profits herself. But the funds she paid subcontractors that belonged to Akins were used to build houses in which Akins did not participate. Clearly her conduct in setting up a shell corporation (J-Max) to pay subcontractors accomplished the building of homes; she simply skimmed off the top some of the monies for herself that would have gone to Akins.

This case deserves a full and complete trial that will present all the facts how Tate did further her master's purposes. Akins' only relief for the theft of his money, practically speaking, is against the employer who partially benefitted and totally had the right of control over Tate
