BRIEF OF THE APPELLANT

Statement of the Issues and of the Case.

I, LONNIE WARDEN, M.D.O.C. #109409, comes before the Court on Brief of the Appellant to Review and Reduce Sentencing, and ask the Court to review the sentencing in my case, as well as the sentencing in the cases of the other men that I have sent to you. I am asking this Court to overturn my sentence or to give me time served on my sentence. Article 3, Section 14 of the State Constitution guarantees due process of law including fair and impartial trial. I feel that the sentence that was imposed upon me was an unjust sentence as compared to the sentencing orders of the other defendants. (Sentencing orders attached herewith).

Petitioner would present and show unto the court that Defendant Thomas J. Knight had the same charges as Petitioner and Petitioner is a first-time offender as Thomas J. Knight, but Knight received a sentence not to exceed five (5) years contrary to Petitioner's sentence who was sentenced to 20 years.

Petitioner would present and show unto the court that Defendant Stacy Bynum had the same charges as Petitioner as a first-time offender as Petitioner, and Bynum received a one year sentence with three years to serve on Post Release Supervision as contrary to Petitioner's sentence who was sentenced to twenty years.

Petitioner would present and show unto the court that Defendant Michael Bonner was sentenced to five years in the custody of the MDOC for Transferring of a Controlled Substance, as contrary to Petitioner's 20-year sentence.

Petitioner would present and show unto the court that Defendant John Shows was sentenced to serve only five years in the MDOC with one year suspended and do the remaining four years on probation, as contrary to Petitioner's 20-year sentence.

I feel that my sentence as set by Circuit Court, as a first-time offender on the same or similar drug charges as other first-time offenders that received a lesser sentence than Petitioner is arbitrary and capricious and unreasonable as to the laws and facts and would respectfully ask the court to review my brief and facts for reconsideration of my 20-year sentence.

Being that I am a first-time offender, I feel that the time that I have served is more than enough time. With this, I want the Court to know that I, Lonnie Warden, made a big mistake in my life getting involved in drugs. I have hurt my family and my children, and grandchildren by being where I am.

This has been a long six years for me and my family. I have changed my life; I now have God in my life, and he has forgiven me. I have also received forgiveness from my family and children. I am asking this court to reconsider the sentence that was imposed on me, and give me a chance.

When considering the sentencing imposed on the other men, and the hundreds of other first-time offenders that have only have five years or less to serve, or probation to serve, I don't feel like it was fair to me to be singled out, to have my life taken away. I just don't see where this is fair to me. Please consider the other cases, sentencing orders of which is attached. In one case you will find one of the men is a habitual offender, who received a twenty-year sentence as I did. But even he had fifteen suspended, with two years to serve, and three years on pre-release.

In the cases that I am attaching of sentencing orders, the men have five years or less to serve. I don't see where I should have to be singled out like this. Why could I have not received the same as the other offenders? As I've said, this has been a hard six years for me and my family. I know that I have learned a lesson, and I do not want anything to do with drugs or alcohol anymore. I have been clean for the last six years, and it feels good. I plan on spending the rest of my life drug and alcohol free.

SUMMARY OF THE ARGUMENT AND ARGUMENT.

As you will see in my file, I have taken Drug and Alcohol classes, and other classes, to do all I

can to better myself. I work everyday, and have not missed a day of work in four years. I would like

to be able to go home and restart my life. I will be 45 years old in October. As it stands right now, the

earliest I will be going home would be 2015, with that putting me doing six more years.

Please consider placing me on probation and let me become a productive citizen in our state. I

have served minimum time of six years, Miss. Code Ann. 1972, 41-29-139 (c)(1) (D). I will be a

benefit to society upon my release in these ways:

1. I will work hard (I have a letter for a job pending my release).

2. I will pay restitution.

3. I will have a place to live and be no harm to society.

4. I will pay taxes and social security, and contribute to the well being of mankind.

CONCLUSION.

I would like to be able to restart my life over before I am not able to work any longer. I feel

that I have paid my debt for my crime, and would like the State to ease the suffering and distress that is

on me and my family and children. I pray to God that this Court of Appeals will find the sentence

imposed on me unjust and an unfair sentence, and that the Court will have compassion enough to

overturn this sentence and give me a chance to prove that I can abide by the laws of our State.


