STATEMENT OF THE CASE

This appeals proceeds from the Circuit Court of Copiah County, Mississippi, and a judgment of conviction for the crime of taking possession of and taking away of an automobile, resulting in a five (5) year sentence and completion of the Regimented Inmate Discipline Program following a jury trial on March 2, 2010, Honorable Lamar Pickard, Circuit Judge, presiding. Catchings is presently incarcerated with the Mississippi Department of Corrections.

FACTS

On or about September 17, 2009, Jeremy Catchings, Alebsion Williams, and Jerry Powell decided to ride their bicycles from Crystal Springs down to Hazlehurst. Tr. 29. As it started to get dark, the three boys decided to ride back to Crystal Springs. *Id*. On the way back to Crystal Springs, Powell stopped at or near Sun-Belt Heavy Haulers. Tr. 30.

According to the testimony of Powell, Catchings went onto the property of Sun-Belt Heavy Haulers and was driving trucks around the back. *Id.* Powell stated that Catchings drove out of the gate with the truck. *Id.*

Williams testified that on the way back to Crystal Springs, all three boys decided to stop for a restroom break. Tr. 23. Williams then noticed that a truck was coming out of the gate at Sun-Belt Heavy Haulers. *Id.* Williams claimed that Catchings was driving the truck. Tr. 25. Williams further stated that Catching drove past them, and blew the horn and waved. *Id.*

According to the testimony of Catchings, he admitted that he took the truck from Sun-Belt Heavy Haulers. Tr. 46. However, he also testified that he never had any intention of keeping the truck. Tr. 44. The only reason Catchings did not take the truck back was that it was too far and was late. *Id*.

Catchings also told the court that Detective Spell told him that this was just a joy ride. Tr. *Id*. He told Catchings that everything was going to be all right and that he would take care of everything. *Id*.

Catchings was subsequently charged and convicted of taking possession of and taking away of an automobile. Catchings is presently incarcerated with the Mississippi Department of Corrections.

STATEMENT OF COUNSEL

1. Counsel for the Appellant hereby represents to the Court pursuant to *Lindsey v*.

State, 939 So.2d 743 (Miss. 2005), that counsel has diligently searched the procedural and factual history of this criminal action and scoured the record searching for any arguable issues which could be presented to the court on Mr. Catchings behalf in good faith for appellate review, and upon conclusion, has found none.

- 2. - 3. Counsel further confirms that he has, as of the date of filing this brief, mailed by first class mail, postage prepaid, a copy of this brief and correspondence informing Catchings that counsel finds no arguable issues in the record and that Catchings has a right to file a pro se brief.
- 4. Counsel for appellant requests that the Court grant Catchings 40 days of additional time in which to file a pro se brief if he desires to do so.
